

Table numbers fell, especially in night duplicates






Note: Total includes supervised and congress (VBA congresses are in Dec & Apr each year)


Improved revenue had limited impact on net loss





Large duplicate decline masked improved performance elsewhere






Loss decreased by \$6,585 (in line with projections last year)

Auditor Appointment



Resolution 1:

To consider and if thought fit pass the following resolution as an ordinary resolution.

"That LZR Audit and Assurance Pty Ltd be appointed as auditors for the financial year ending 31 August 2019"

Life membership



Resolution 2:

To consider and if thought fit pass the following resolution as a special resolution.

"That Mr Ben Thompson be made a life member of the VBA."

Explanatory note

Mr Richard Rozen OAM proposed that this motion be put at the 2017 AGM. In accordance with clause 7(b) of the Articles of Association, this resolution is put pursuant to a recommendation of the VBA Council. (The President abstained from this recommendation)

Special Business



- Resolutions 3, 4 and 5 concern changes to the VBA's Articles of Association
- Notice has been given in accordance with articles 16 and 17 of the Articles of Association
- As special resolutions, at least 75% of votes are needed to pass
- Explanatory notes were provided with the AGM papers

50 Year Membership



Resolution 3:

To consider and if thought fit pass the following resolution as a special resolution.

"That Clause 7(c) of the Articles of Association be amended to:

Honorary Members: Honorary Members shall be persons so designated by resolution of the Council not being ordinary or life members of the Company. Honorary membership may be granted for any period up to twelve months, and extensions may be granted by further resolution of the Council if the Council should so determine. The Council shall by resolution designate members with fifty years' continuous service to the Company as Honorary Members without limitation as to duration. During the term of their honorary membership, Honorary Members shall be entitled to enjoy without payment of any fee the rights of membership of the Company, and shall be bound by the Memorandum and Articles of Association of the Company except that their names shall not be entered upon the register and they shall not be liable to make any contribution in the event of the winding up of the Company as provided in the Memorandum."

Explanatory note

The Council resolved that a member who has achieved 50 years of continuous service will be made an honorary member. The current clause requires council to "re-approve" the decision annually. The new clause, with added text marked in red, will remove this administrative requirement for this class of member.

Change Secretary position to accord with Corporations Act



Resolution 4:

To consider and if thought fit pass the following resolution as a special resolution.

"That Clause 31 of the Articles of Association be amended to:

The Council shall consist of the President, two Vice-Presidents, the Treasurer, not more than five Ordinary Councillors and not more than four Special Councillors. Special Councillors must be financial members of an affiliated club in that zone of Victoria, as prescribed in the regulations, in which they have nominated for election. No employee or other person holding an office of profit under the Company shall be eligible for election to the Council. The duties of members of the Council shall be determined from time to time by the Council. The Council shall appoint a financial member, including councillors but excluding the Officers, as Secretary of the Company."

Explanatory note

The Corporations Act (2001) specifies that the Company Secretary shall be appointed by the Board of Directors (in terms of the Act, the VBA's Board of Directors is the Council). This change to clause 31 (i) replaces the Secretary position on Council with an Ordinary Councillor position and (ii) directs Council to appoint a financial member of the VBA as Secretary.

Remove Secretary from list of Officers



Resolution 5:

To consider and if thought fit pass the following resolution as a special resolution.

"That Clause (h) in the Notes of the Articles of Association be amended to:

h) "Officer" means President, Vice-President and Treasurer of the Victorian Bridge Association elected in accordance with article 33 and includes the meaning assigned to "Director" by section 5(1) of the Act."

Explanatory note

"Secretary" would be removed from Clause 1(h), which defines the Officers of the VBA. This change supports Resolution 4, together bringing the Articles of Association into accord with the Corporations Act (2001) regarding the position of Secretary

A Harsh and Unpleasant Reality



VBA Duplicates now lose money

- Break-even is about 8.5 tables per duplicate session
 - Saturday exceeds this mark
 - Monday am can reach this mark
 - Thursday am & pm well short
- Duplicate table numbers fell from 4,224 in 2010 to 1,476 in 2018
- Competitions run profitably (after supporting our Interstate teams)

An Alternative Model?

- We are forced to consider what the VBA would be like without running duplicates (or supervised)
- In brief, we would have to:
 - Sell the building
 - Hire space for 2 competition sessions / week
 - Help duplicate players find a new club to play at
