Treasurers Report For the Year Ended 31st August 2012

This report should be read in conjunction with the Financial Statements of the VBA. These were provided to all members in November and are also available for download on the VBA Website.

Key Points

- Net Loss for the year \$27,861 (Prior year \$27,132)
- Club Bridge revenue down 8.7% to \$143,000
- VCC Surplus of \$9,500 (prior year loss \$14,000)
- State Bridge Playing Revenue down 14.3% to \$54,000
- Costs relatively static overall. Most costs are relatively fixed.
- Land Tax refund of \$7,500 achieved thru representation to State Revenue office
- Net Cash on Hand 31st August \$273,000 (prior year \$305,000)
- Capital Expenditure (predominantly IT Infrastructure and airconditioning) \$28,000. Funding to be recovered from VBA Foundation for IT Infrastructure
- Draft budget showing potential loss for this year of \$20,000.

The VBA suffered its second year of losses in a row. In the past two years the losses have totalled \$55,000 and the Council is looking at ways to stem these. It will be the key objective of the incoming Council.

Whilst the VBA still has cash reserves of \$273,000 it needs to maintain good levels to fund asset replacement, building maintenance and other contingencies. It must endeavour to reduce the budgeted loss in 20113 and break even in future years. This may require a substantial review of operations, strategies, objectives and purpose. The suitability of the building at Poath Road for the VBA is being considered and a move is a possibility.
